### Firestopping investigation works week commencing Monday 17 April

We have been notified by the original developer of your buildings Fairview about a comprehensive review of internal firestopping measures within your blocks. They have agreed to carry out these investigations at no cost to Network Homes and our residents. Fairview will pay for these investigations, including making good any areas opened for inspection.

They have appointed their contractor TP Group to carry out these investigations starting on week commencing **17 April**. The duration of the assessment will be around five days. The investigations require opening/cutting out parts of walls and ceilings, which they will put back and repair as needed. Therefore, please be extra mindful on the days the investigations take place.

The majority of the investigations will take place in the common parts of the buildings however, they will require access to a sample to flats to check flat entrance doors. Fairview will contact those residents separately.
