#### **EWS1** form available

I am pleased to be able to confirm that the external wall system remediation is now complete. There remain a few outstanding tasks for Higgins to complete such as the landscaping and an external clean.

The majority of the car parking spaces have been returned along Thornton Street; the car park located at the end of Thornton Street which is currently being used as Higgins Site compound it is hoped will be returned in August.

Our fire engineer KIWA has carried out a site inspection and has now issued an EWS1 form (EWS – external wall system). This certificate confirms that your building has been rated as 'B1 – the fire risk is sufficiently low that no remedial works are required'.

For those of you who have been looking to sell or remortgage, we hope that this will help you to do so. And for all of you, we hope this provides you with the peace of mind that the fire risk is sufficiently low.
