Remediation work Update

The building owners have sent us the latest programme update for Shams Court and we summarise this below.

Although anticipated completion dates are stated, from previous experience, these may be delayed. We ask you to treat these as indication only – not firm.

General

Works are 85% complete to rear and side elevations.

Rear Elevation

• the final stages are to install the permanent insulation and cladding panels by end of October. The scaffolding is due to be removed by end of November 2024.

Side Elevation

Permanent Insulation and the final cladding panels will be installed by end
of October 2024. The scaffolding will start to be removed in December 2024
and we would suggest given Christmas shutdown that it will be removed
fully by end of January 2025.

• Permanent Insulation and the final cladding panels will be installed by end of October 2024. Removal of scaffold to start in December 2024. As above, given Christmas shutdown this may mean fully removed by end of January 2025.

Front Elevation (2nd Half)

- Scaffold now erected.
- Strip of insulation from by end of September 2024.
- Install of Fibre Cement Board by Mid-September 2024
- Waterproofing around windows and Breather membrane installed by end of September 2024.
- Installation of metal channels and fire barriers by end of October 2024.
- Removal of scaffold by end of December 2024. As above, given Christmas shutdown this may mean fully removed by end of January 2025.
